FALLBROOK HISTORICAL SOCIETY BY LAWS

Revised May 3, 2002

ARTICLE 1 - NAME

- 1. The name of this organization shall be: Fallbrook Historical Society, Inc.
- 2. The office of this Society shall be in San Diego County, California, at 260 Rocky Crest Road, Fallbrook.

ARTICLE II - PURPOSES

- 1. The purposes of this organization shall be charitable, scientific, literary and educational, with particular emphasis upon bringing together those persons interested in the history of the Fallbrook area (Fallbrook High School District) and the preservation of its artifacts.
- 2. The Historical Society shall exist and operate as a nonprofit, nonpolitical organization and shall not discriminate as to age, sex, race or creed, or participate or intervene in any political campaign on behalf of any candidate for public office as detailed in the organization's Articles of Incorporation.

ARTICLE III _ TAX-EXEMPT STATUS

- 1. In order to maintain tax-exempt status established under Section 501© 3 of the Internal Revenue Code and Section 23701d of the Revenue and Taxation Code, no part of the profits or net income of this corporation shall ever inure to the benefit of any director, officer, or member. The Society shall not promote the private or commercial interests of any member. No individual member or organization shall have any financial interest in the property or assets of the Society. No member shall use the Society's name or membership list for personal profit or any use not for the benefit of the Historical Society.
- 2. The Society shall not engage in any fundraising efforts in which the profits are shared with individual Society members. All profits from any fundraising where financial support is solicited from outside the Society's membership must be used for preservation, restoration or maintenance of the Historical Society's facilities. Fundraising exclusively within the membership may be used to supplement treasury.

ARTICLE IV - MEMBERSHIP

- 1. Membership in the Society shall be composed of those individuals who the purposes of the Society and agree to abide by its Bylaws. Any member shall automatically forfeit membership in the Society upon violation of any of its Bylaws.
- 2. The Society shall have eight (8) classes of membership. The class shall be distinguished by the amount and method of payment of dues.
- 3. Classification of membership paying dues annually.
 - a. Family
- b. Single Adult
- c. Junior (up to age 18)

- d. Contributing
- e. Business and Professional
- 4. Classification of single payment membership
 - a. Life
- b. Patron
- c. Honorary
- 5. The Board of Directors shall determine the amount of dues and specific requirements for each class of membership. Annual dues shall become payable May 1st the beginning of the fiscal year and delinquent after three months.

ARTICLE V - OFFICERS AND DIRECTORS

- 1. The elected officers of the Society shall be president, vice-president, recording secretary, corresponding secretary and treasurer.
- 2. All officers shall serve a term of one year and shall be elected annually by a voice vote with a majority necessary to carry the vote.

- 3. The officers of the Society shall be elected from among the Board of Directors at the next regular meeting following the Annual Meeting of the Society. Officers and Directors shall serve until a successor has been elected.
- 4. Should any vacancy occur during a term of office, it shall be filled by a majority vote at the next regular board meeting.
- 5. The Board of Directors shall be comprised of fifteen (15) active members in good standing. Their term of office shall be three years with one-third (1/3) elected each year.
- 6. The President of the Board shall select a Nominating Committee Chairman no later than the January meeting. The Board shall select at least two additional Society members to serve on the Committee.
- 7. The Nominating Committee shall present the names of candidates to the Board no later than the February Board Meeting. Only Society members in good standing are eligible to vote, hold office or Board membership.
- 8. The election of Directors shall be held at the Annual meeting. Nominations may be made from the floor with prior consent of the nominee; if there are none, the vote shall be by voice vote with the candidates receiving the highest number of votes elected. If there are additional nominations, the election shall be conducted by written ballot. No proxies will be counted.

ARTICLE VI - DUTIES OF OFFICERS

1. The President shall:

- a. preside at all meetings of the Society and shall have general supervision of all Society activities.
- b. appoint, with board approval, a parliamentarian and committee chairmen as needed.
- c. be an ex-officio member of all committees except the nominating committee.
- d. perform such other duties as pertain to the office.

2. The Vice President shall:

- a. assist the president as requested.
- b. perform the duties of the president in his/her absence.

3. The Recording Secretary shall:

- a. record the proceedings of all meetings and provide a written copy to the president and treasurer at least one week before the next scheduled meeting.
- b. have charge of all records and current documents pertaining to work of the Society.
- c. maintain a permanent copy of the Articles of Incorporation, Bylaws, Standing Rules and Minutes and any amendments to these documents.

4. The Corresponding Secretary shall:

- a. handle all incoming and outgoing correspondence of the Society and maintain a file of all business correspondence.
- b. notify board members of a revised meeting schedule.
- c. send condolences, get well and thank you notes as directed.
- d. in the absence of one of the secretaries, the other shall be prepared to temporarily assume the duties of both, at the direction of the President.

5. The Treasurer shall:

- a. be custodian of all funds belonging to the Society, depositing the receipts promptly in the bank and disburse monies as directed by the board.
- b. keep accurate records of all transactions and prepare a written report to be read at the next board meeting.
- c. submit books for audit promptly at the close of the fiscal year to a qualified non board member selected by the board and provide required data to the accountant for taxes.
- d. Update bank signature cards within thirty (30) days after the close of the term of office.

6. Execution of Checks, Notes and Contracts:

- a. All checks, drafts, promissory notes, orders for payment or other instruments of indebtedness of the Society shall be signed by the Treasurer and countersigned by the President or Vice-President.
- b. Any lease, contract, or other instrument executed in the name of the Society shall be signed by the Recording Secretary and countersigned by the President or Vice-President.

c. Any of these documents shall have attached to it a copy of the resolution of the Board of Directors, certified by the secretary, authorizing its execution.

ARTICLE VII - DUTIES OF DIRECTORS

- 1. The Board shall conduct all business of the Society and shall be comprised of fifteen (15) members in good standing.
- 2. The Board shall provide to the annual election of Directors. Each Director shall be elected for three (3) years with one third (1/3) elected each year.
- 3. The Board shall set the amount of all dues and shall be responsible for annual budgets, any fundriising activities and arrange for the annual audit of the books.

ARTICLE VIII - MEETINGS

- 1. The regular meeting of the Board of Directors shall be held monthly on the first Tuesday at a time and place designated by the Board of Directors.
- 2. Special meetings may be called by the President, by any three or more Board members or by twenty (20%) percent of the general membership.
- 3. Notice of the Annual Meeting and any special meetings will be given to members at least seven (7) days prior to the meeting.
- 4. A quorum at any general meeting shall be twenty-five (25) or more members in good standing. A quorum of any Board of Directors meeting shall be six (6) or more Directors, including at least three (3) elected officers

ARTICLE IX - AMENDMENTS

1. These Bylaws may be amended at any regular or special meeting by a two-thirds (2/3) vote of members present provided a written notice has been given to all members at least two weeks prior and an updated copy of the revised Bylaws provided to each Board member.

ARTICLE X - PARLIMENTARY AUTHORITY

1. The current edition of *Robert's Rules of Order, newly revised*, shall govern the proceeding of this organization in all cases not provided for in these Bylaws and the Articles of Incorporation.
